



Jack Andes, President, Baldwin Highlander Music Patrons, called the meeting to order and offered welcoming remarks at 7:40 pm.

**Report of the Secretary:** Holli Smith presented the following report:

- 1) The minutes for the General Meeting held February 16, were presented and revisions were to be made. A copy of the revised minutes will be made available at the next meeting.
- 2) Incoming Correspondence: The following items were received.
  - a) Baldwin Whitehall School District (BWSD) letter dated February 25, 2010 indicating receipt of partial payment of \$6447.78 from Baldwin Highlander Music Patrons (BHMP) sent on February 18, 2010. The letter requests additional payment of \$6168.23 and the BHMP signature to a Letter of Agreement in compliance with BWSD policy 707 recognizing the BHMP be classified in Group 2, a student support group. Further statements indicate that the permit to hold DCI on July 8, 2010 will be released pending the resolution of these two items.
- 3) Outgoing Correspondence: The following items were sent on behalf of BHMP:
  - a) In correspondence dated February 18, 2010 from the "Desk of Andes", to Mr. McKain, Director of Administrative Services, a copy of the paid receipts for past DCI invoices owed by BHMP to BWSD and a BHMP check in the amount of \$6447.78.
  - b) Correspondence authored by Jack Andes, President, BHMP to Dr. Korchnak, Superintendent of BWSD, dated March 1, 2010, reflecting receipt of a request from BWSD requesting additional payment in the amount of \$6447.78 for services rendered by BWSD and reaffirming the position of the officers of BHMP in reference to said request.
  - c) A Fax Memorandum authored by Jack Andes, President, BHMP, to Dr Korchnak, Superintendent of BWSD, dated March 5, 2010 proposing the BHMP response and revised Letter of Agreement between BHMP and BWSD.
  - d) A letter authored by Jack Andes, President, BHMP to Dr Korchnak, Superintendent of BWSD dated March 9, 2010 reflecting upon the past practices of the BWSD in reference to the transportation costs associated with equipment transportation to competitions.
- 4) The next meeting will be held April 20, 2010 with the election of officers.

**Report of Treasurer:** Bob Smith, treasurer, made available a copy of the Treasurer's Statement from February 15, 2010-March 15, 2010 and made the following report:

- 1) A check was reported lost/not received by Delallo's for payment of January Hoagie expenses. Hence, the amount listed for hoagies expenses reflects two payments with a voided check listed as a line item credit
- 2) The report also includes a check written to Cedar Point for a proposed trip by the Baldwinaires in May, 2010.
- 3) The balances were corrected as stated by Bob Smith and the report approved..

**Report from Board of Directors Meeting:** Jack Andes, President, made the following report:

- 1) An Executive Board meeting was held on March 8, 2010 in which BWSD policy 707 was discussed. BWSD considers BHMP to be located in Group 2, School Support Groups, whereas BHMP considers itself to be in Group 1 as Student Activity Groups. The result of this meeting was to encourage the membership to attend the School Board Meeting held on March 10, 2010.

- 2) There were several BHMP members present at the School Board Meeting of March 10, 2010 to express their concerns about the current position of BWSD in reference to BHMP.
- 3) The Board of Directors has approved a motion to remit \$6168.23 to BWSD for costs associated with transportation of equipment trailers to USSBA competitions held in November, 2009.
- 4) The Board of Directors voted not to permit signature of BWSD letter placing BHMP in Group 2 of Policy 707.
- 5) BHMP President Jack Andes will contact Mr. McKain, Director of Administrative Services for BWSD regarding the path forward and to resolve questions regarding future transportation issues.
- 6) Progressive Music was approved as a co-sponsor of the upcoming DCI event scheduled for July 8, 2010.
- 7) The DCI permit was released by BWSD on March 12, 2010.
